## **3 Year Limited Warranty**

- 1. Warranty Coverages: WNL Products offers a three year limited warranty against any defects in workmanship or materials under normal use with respect to its Practi-TRAINER® AED Trainer and Practi-TRAINER® Essentials AED Trainer.
- 2. **Warranty Period:** WNL Products warrants the Practi-TRAINER® AED Trainer and Practi-TRAINER® Essentials AED Trainer for three years from the date of purchase. Any component of the Practi-TRAINER® AED Trainer and Practi-TRAINER® Essentials AED Trainer which proves defective with thirty-six months from the date of purchase will replaced free of charge to the owner. The owner is not responsible for shipping and handling fees to replace a defective trainer.
- 3. Warrantor's Responsibilities: WNL Products will replace a defective warranted component as stated in Section 2 free of charge. Replacement of any component of any Practi-TRAINER® AED Trainer and Practi-TRAINER® Essentials AED Trainer does not extend this limited warranty or begin a new limited warranty period.

## 4. Circumstances Negating Warranty and Other Limitations:

- A. WNL Products reserves the right to refuse warranty service or replacement when product failure is due to misuse, mishandling, misapplication, accident, neglect, improper installation, modification, use of unauthorized parts or attachments, adjustments or repair performed by anyone other than WNL Products or its authorized distributors, or any causes other than defective workmanship or material.
- B. This limited warranty does not cover abrasion, abnormal use, damage caused by mishandling, neglect or unauthorized modification. This warranty is void if the Practi-TRAINER® AED Trainer and Practi-TRAINER® Essentials AED Trainer is structurally altered.
- C. Owner must provide proof of the date of purchase and place of purchase in order to obtain service under this limited warranty.
- D. WNL Products makes no warranty other than as contained herein. No agent, representative, dealer or employee of WNL Products has the authority to alter the obligations or limitations of this limited warranty.
